

Terms and Conditions of the Participation in the .com Campaign

June, 2021

Openprovider B.V. , hereinafter referred to as Openprovider, temporarily offers a contest related to new .com registrations with Openprovider. Participation is free, you only need to be an active Reseller of Openprovider.

1. Definitions

- 1.1. **Race** is the name of the contest on new .com TLD registrations.
- 1.2. **Reseller** is an active customer of Openprovider;
- 1.3. **Token** is a point which each reseller receives for every 10 registered new .com within the period of the Race, after meeting the baseline targets;
- 1.4. **Baseline** is a normal run rate of new .com registrations for a specific period of time which is based on the number of registered .com.
- 1.5. **Membership plan** is a yearly subscription plan which gives access to Openprovider cost prices on domains and other products, Marketing Funds and personal Account Manager, depending on the size of a Membership;
- 1.6. **Membership fee** is the amount which is paid for a yearly Membership Subscription. It varies depending on the size of a Membership Plan.
- 1.7. **Reseller Control Panel (RCP)** is a panel where each active customer of Openprovider can manage all their activity, invoices, renewals, new registrations, change of plan etc.

Participation is the subject to the following conditions:

2. Conditions of participation

- 2.1. Participation in the Openprovider race is done through the Reseller Control Panel and a Landing page provided by Openprovider. The participant must be an active Reseller of Openprovider. By being a Member of Openprovider and start registering new .com domains, you automatically enroll in the competition and accept these Terms and Conditions.
- 2.2. Automatic enrollment does not imply any additional charges.
- 2.3. A prerequisite for participation in the online competition is starting purchasing of a specific TLD: .com.

3. Eligibility

- 3.1. All the active resellers of Openprovider who registered .com before or want to start registering .com are eligible to participate.
- 3.2. Employees of Openprovider, other persons directly involved in the development and implementation of the competition, as well as family members of the persons listed above are not allowed to participate.
- 3.3. Openprovider will disqualify a participant if there is reason to believe a breach of conditions, double participation or other unfair manipulation in the Race, such as violation, threats and / or harassment of Openprovider employees, abusive .com

domains registration. In such cases, Openprovider also has the right to retroactively forfeit the winnings and claim the prizes awarded.

- 3.4. The count of the Tokens starts by reaching the baseline for the same period of 2020, or by registering a minimum number of 10 new .com domains in case there is no .com registration history for the same period of the year 2020.
- 3.5. One Token is earned for every 10 legally registered new com. Abusive domains are not included in the count.

4. Prizes

- 4.1. The corresponding prizes are the result of the respective race. Prizes size and value will not be varied and the participants will not have the right to select another item of the same value and quality for the winner as a prize.
- 4.2. Any additional costs associated with the use of the prize, such as additional equipment or fees required, are the responsibility of the winner.

5. Terms of the competition

- 5.1. Participation in this competition is only possible within the competition period specified by Openprovider in the respective application.
- 5.2. With the end of the competition period, the opportunity to participate automatically disappears.
- 5.3. The period for participation of the Race is Quarter 2, 2021 and ends on the 31st of June, 2021, at 23:59.

6. Selection / announcement of winners / transfer of prizes

- 6.1. According to the conditions of the competition, the winners will be chosen by lot. The drawing of lots is carried out with a sufficient randomness principle online.
- 6.2. The selection will take place within 5 working days after the end of the race.
- 6.3. Each participant can only win once per quarter. Transfer of winning to other resellers is not possible.
- 6.4. Winners will be notified of their winnings within 48 hours of their selection on behalf of Openprovider via email address provided in the database of Openprovider.
- 6.5. Delivery of the prizes to the resellers is done within 48 hours after the selection.

7. Termination of the competition

- 7.1. Openprovider reserves the right to terminate or discontinue the competition or prize draw at any time for good reason without prior notice. This is especially true for reasons that disrupt or impede the planned competition or prize draw.

8. Final Provisions

- 8.1. Everything that is not covered by these Terms & Conditions falls under the regulations of the [General Terms and Conditions](#) of Openprovider.
